Richard Kruger with Kruger and Abell Law Firm attended the meeting on behalf of the Port District. They have contracted to have a feasibility study done on the Brookport Dam and Vistra (the old EEI plant). He is asking for \$300,000 in funding for the Port District and to hire someone to help with these projects. Mr. Kruger explained what the old Brookport Dam would be used for. Mr. Farmer explained that the Energy Transition Grant years 1 and 2 are already allocated, but year 3 would be a possibility. Mr. Farmer asked if the county would ever be repaid for the \$300K, and Mr. Kruger replied they could draw up an Intergovernmental Agreement. The commissioners agreed they would discuss it further and follow up.
