

MINUTES  
MASSAC COUNTY BOARD OF COMMISSIONERS  
Special Meeting-Administrative Hearing  
January 16, 2026

Meeting convened at 10:00 A.M. with Jimmy Burnham, Jeff Brugger, and Jayson Farmer present.

Chairman Jayson Farmer called the meeting to order. Roll call was taken by Hailey Miles, County Clerk & Recorder.

On a motion by Mr. Brugger, 2<sup>nd</sup> by Mr. Burnham, the commissioners voted to make the following documents a part of the record of these proceedings:

- a) Record of Proceedings before County Board on December 1, 2025
- b) Dismissal of Gary Hamm as Massac County Supervisor of Assessments
- c) Rules of Procedure for Hearing on Dismissal of Massac County Assessor
- d) Notice of Dismissal letter dated December 1, 2025 from Jimmy Burnham, Chairman of the Board of Commissioners to Gary Hamm.
- e) Notice of Hearing sent to Gary Hamm and Attorney Darrell Dunham on January 8, 2026.

Gary Hamm’s attorney, Darrell Dunham, stated Gary’s constitutional rights were violated due to the fact that he did not have a pre-termination hearing. Mr. Dunham asked the Board to reinstate Mr. Hamm and back date his pay. Attorney Rick Abell, representing Massac County, suggested they deny the request.

On a motion by Mr. Farmer, 2<sup>nd</sup> by Mr. Burnham, the commissioners denied the request.

Mr. Abell called Josh Reagor, former Supervisor of Assessments for Pulaski County and Massac County resident. Mr. Reagor was sworn in and questioned. Mr. Dunham also questioned Mr. Reagor and Mr. Abell had some follow up questions.

Mr. Abell called Supervisor of Assessments deputy Chesley Ablett. She was sworn in and questioned. Mr. Abell presented County Exhibit 1. Mr. Dunham then questioned Mrs. Ablett and showed her Exhibit c, previously presented.

Mr. Abell called Supervisory of Assessments deputy Allie Davis. She was sworn in and questioned.

Mr. Dunham called Gary Hamm back as a witness and questioned him further.

Mr. Dunham gave his final statements, stating no proof of any of the claims against Mr. Hamm and suggested they re-instate Mr. Hamm.

Mr. Kruger gave his final statement on behalf of the county, and encouraged the commissioners to not reverse their statement.

Mr. Farmer made a motion to decline the motion by Mr. Dunham to re-instate employment, 2<sup>nd</sup> by Mr. Brugger.
